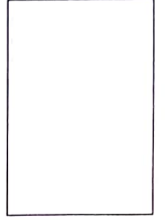

TERMS & CONDITIONS:

1. Period of Engagement:

- 1.1 Initial contract would be for a period of 3 months extendable for a further period as may be decided by the Council. However, the maximum period of engagement will be Five years.
- 1.2 The engagement of LAB ATTENDANT would be on **FULL TIME BASIS** and required to work on holidays also, if need be, for which no additional fee will be paid.
- 1.3 The engagement of Lab Attendant is of a Temporary Nature and the engagement can be terminated at any time without assigning any reason. This re-engagement shall not be considered as a case of re-employment.

2. Age Limit:

Applicants who were already retired as on the last date of receipt of the application and are not more than 65 years of age on the last date of receipt of the application can apply.

3. Entitlements :

- 3.1 **Remuneration Fee:** The person so engaged as Lab Attendant will be paid consolidated Fee equivalent to his/her Last Pay Drawn (-) Minus 50% of his/her Last Pay Drawn (or) to the Maximum of Rs. 20,000/- per month.
- 3.2 **Allowances:** The person so engaged shall not be entitled to any allowance such Dearness Allowance, Medical Reimbursement etc.,
- 3.3 **Leave:** The person so engaged shall be eligible for 8 days leave in a calendar year on pro-rate basis. Any un-availed leave in a calendar year cannot be carried forward to next calendar year.

4. Office Time and Working Hours:

Engagement of Lab Attendant would be on full time basis. Working hours shall be from 8.45 A.M. to 5.00 P.M. during working days including One hour lunch break in between. The Lab Attendant may be called on Saturday / Sunday Other Gazetted holidays, if required.

5. The Council Reserves the right , which is as follows:

To cancel this Notification in respect of this post and not to proceed in the matter. At any stage accept or reject any or all applications without giving any explanation , whosoever change any term & condition of this Notification.

6. Selection Procedure:

Application received in response to this Notification will be shortlisted on the basis of experience and qualification of the applicant. Only shortlisted candidate will be intimated and PAJANCOA & RI reserves the right to reject any or all application without assigning any reason.

7. Termination of Agreement:


The Council may terminate a contract to which these Terms & Conditions apply if:

Termination shall be in written notice served to the person so engaged and shall take effect in 15 days of delivery of such notice, the termination shall be without prejudice to either party's right accrued before termination.

The contract shall be governed by and construed in the accordance with I.D. Note / Memorandum No. 46324/FD/F3/2014 dt. 11.09.2014 of the Finance Department, Puducherry.
